A general legacy to the Vine Trust makes a difference, for example:

£1,000

Runs a Night Shelter for two months, reaching out to hundreds of abandoned kids

£5,000

Provide full time residential and educational opportunities for ten children for a year

£25,000

Covers our UK office's core running-costs for a year

£50,000

Runs one of our medical ships for an entire year, treating up to 50,000 patients and visiting over one hundred communities

£100,000

Finances a new residential facility for street children, providing education together with revenue generating activities from tourism

As we look towards the future we are aware of the continuing growth the Vine Trust is experiencing and hope to realise the provision of a modest, but permanent, office base for the Trust in the UK.
